 - o 10-12 kumu at jeopardy, leaving basically none left because of admin leadership/po'o
 - o Hui Makua is newly started
 - After 2 HSTA grievances filed from Q1, pressure on DOE finally happening. Trying to show the DOE that this isn't an isolated problem only at Ehunuikaimalino And to prevent her from being passed on to another kula. Looking to establish a hiring process for Admin that includes kaiapuni and is more current than 1988 version & zero of it in ōlelo
 - Looking for testimony and support to help with their efforts

- o cooking for resumerly und support to help with their energi
- HMOP currently does not have a stance because we have not taken a vote as a Hui. Based on past history where Admin / Makala challenged HMOP our bylaws were
- o Move to set-up a hālāwai to discuss as a HMOP proposed by Ka'ano'i; 2nd Jenny/Ku'ulei
 - Special mtg add on discussion to pre-existing FAFKE meeting part 2
 - Section 11 of HMOP Bylaws require 48 hrs notice.
 - Emergency meeting to discuss support of sister kaiapuni Ehunuikaimalino for Monday 3/29 5:30 PM.
- o Had 4 interventions as Hui Makua over:
 - Mis-use of funds
 - Hostile work environment
- o Action Recap:
 - Class action meeting last Thursday 3/18, then launched online petition (paper petition prior)
 - o Monday 3/22 sign waiving which led to front cover of West Hawaii Today
- o Goals:
 - o Looking for quick removal instead of waiting on investigation which could take 1-year
 - Friday 3/26 5PM Prince Kühio sign waving at Kailua-Kona, then printing the 1200+ signatures petition. Have SCC Chair to deliver to CAS Smelling.
- o Wants Makua to have a larger say in who leads the kaiapuni
- o Larger picture a goal
- April 5th deadline to get testimony to CAS
